THREE PAYMENT OPTIONS FOR LOCAL TAXES

Online payment

Advantages

- A quick, commitment-free way to pay all your taxes.
- You give a payment order on each due date from the bank account of your choice either in France or in a country in the Single Euro Payments Area (SEPA).
- You have an extra five days to pay and the amount is debited ten days after the payment deadline at the earliest.
- You can change the amount being debited.

Payment methods

- Online at impots.gouv.fr, by logging on to your personal account.
- By Smartphone or tablet, by scanning the code on your tax notice using the "Impots.gouv" app.



Direct debit on the due date

Advantages

- You will never forget a tax payment.
- You can use the bank account of your choice either in France or in a country in the Single Euro Payments Area (SEPA).
- Your bank account is debited ten days after the payment deadline.
- You are informed prior to each direct debit.
- Your contract is automatically renewed every year.

Signing up

- Online at impots.gouv.fr, by logging on to your personal account.
- By Smartphone or tablet, by scanning the code on your tax notice using the "Impots.gouv" app.
- By telephone from Monday to Friday from 8.30am to 7pm (times in mainland France) on 0809 401 401 (free service + cost of call).

When to sign up

- Until the last day of the month preceding the payment deadline.
- After the last day of the month, your subscription will be valid for the next due date.

Changing your direct debit

- Online at impots.gouv.fr, by Smartphone or tablet or by contacting your tax department.
- Up until the last day of the month preceding the payment deadline.
- You can change the amount of your next payment if you think your taxes will decrease.
- You can change your bank details.

Monthly direct debit

For your property taxes and residence tax on your second home.

Advantages

- You don't have to remember to make payments.
- Your tax payments are spread over ten months.
- You can use the bank account of your choice either in France or in a country in the Single Euro Payments Area (SEPA).
- You are informed in advance of the dates and amounts of the direct debits.
- Your contract is automatically renewed every year.

Signing up

- Online at impots.gouv.fr, by logging on to your personal account.
- By Smartphone or tablet, by scanning the code on your tax notice using the "Impots.gouv" app.
- By telephone from Monday to Friday from 8.30am to 7pm (times in mainland France) on 0809 401 401 (free service + cost of call).

When to sign up

- From 1 January to 30 June: the first direct debit is made on the 15th of the following month.
- As from 1 July, you register for the following year.

Changing the amount of your monthly instalments

- Online at impots.gouv.fr, by Smartphone or tablet or by contacting your tax department.
- You can change the amount of your monthly instalments up to 30 June if you think your taxes will increase or decrease. Changes become effective the following month.
- You can suspend your direct debits during the year if you think that you have paid all your taxes.
- You can change your bank details.

SIGN UP FOR DIRECT DEBITS IN MONTHLY INSTALMENTS OR ON THE DUE DATE

You can sign up for direct debits in monthly instalments or on the due date with a bank account in France or in any other country in the SEPA.

Online

Log on to your personal account on the impots.gouv.fr website. Have your bank details ready. This account is totally secure.

By Smartphone or tablet

Scan the code on your tax notice using the "Impots.gouv" app.

By telephone

You can also sign up for direct debits in monthly instalments or on the due date by telephone from Monday to Friday from 8.30am to 7pm (times in mainland France) on 0809 401 401 (free service + cost of call).

This service can also be accessed from French overseas *départements*.

All taxes over **€300** must be paid by direct debits in monthly instalments or on the due date, or online at impots.gouv.fr, or by Smartphone or tablet.
